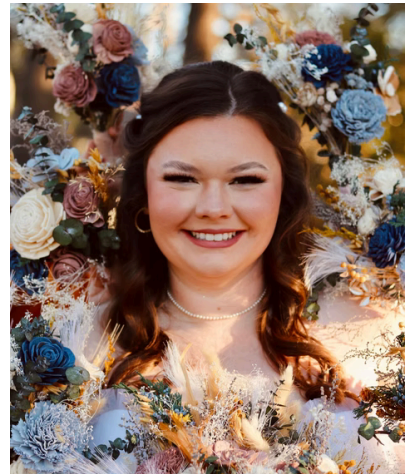

INTIMATE COLLECTION

Three hours of wedding day coverage. This collection is perfect for courthouse ceremonies, elopements, or intimate weddings. Coverage typically includes the ceremony, portraits following the ceremony, and meaningful moments with immediate family. You will receive a fully edited online gallery with high resolution images and full print rights.

Package two

ESSENTIAL COLLECTION

Six hours of wedding day coverage. Ideal for smaller weddings that still want the story of the day thoughtfully documented. This collection usually covers getting ready, the ceremony, portraits, and the beginning of the reception. Includes timeline guidance, a fully edited online gallery, and full print rights.

Package three

SIGNATURE COLLECTION

Ten hours of wedding day coverage. Perfect for couples who want full coverage from start to finish. This collection allows for a slower paced day, more portrait time, and complete reception coverage. Includes timeline guidance, a fully edited online gallery, and full print rights.

A second shooter may be added for \$50 per hour, based on availability.

Travel is included for weddings within two hours of the Austin area. Weddings located more than two hours from Austin may require an additional travel fee. Travel fees are based on distance and, when applicable, overnight accommodations, and will always be discussed in advance.

SAMPLE CONTRACT



Wedding Photography Agreement

This Wedding Photography Agreement is entered into between Norton & Co. Photography, hereafter referred to as the Photographer, and the Client listed below. By signing this agreement, the Client acknowledges that they have read, understood, and agree to all terms and conditions outlined herein.

Scope of Services

The Photographer agrees to provide wedding photography services on the date and at the location listed above for the number of hours selected by the Client. Coverage will begin and end at the agreed upon times. The Photographer will use professional judgment to capture the wedding day in a manner consistent with their artistic style and portfolio.

Artistic Style and Creative Discretion

The Client understands that photography is a subjective art form and that the Photographer's work reflects a consistent creative style. By signing this agreement, the Client confirms familiarity with the Photographer's portfolio and accepts that images may vary due to lighting conditions, weather, venue restrictions, time constraints, and other factors beyond the Photographer's control. Editing decisions, image selection, and final presentation are at the sole discretion of the Photographer.

Deliverables

The Client will receive a fully edited online gallery of high resolution digital images. The number of images delivered is not guaranteed and depends on the events of the wedding day. Raw or unedited images will not be delivered under any circumstances. The Photographer is not required to release original files, unedited files, or rejected images.

Payment and Retainer

A non refundable retainer of 20% is required to reserve the wedding date and is applied toward the total cost of services. The remaining balance is due no later than fourteen days prior to the wedding date. Failure to submit final payment by the due date may result in cancellation of services with no obligation to provide coverage and no refund of any payments made.

Additional Coverage and Add Ons

Additional photography coverage may be added at a rate of \$300 per hour, subject to availability and Photographer approval. A second shooter may be added at a rate of \$50 per hour, subject to availability. The Photographer reserves the right to determine the second shooter assigned.

Travel

Travel is included for weddings within two hours of the Austin area. Weddings located more than two hours from Austin may require a travel fee. Travel fees are determined based on distance and, when applicable, overnight accommodations. All travel fees will be discussed and agreed upon prior to the wedding date.

Client Responsibilities and Cooperation

The Client agrees to provide an accurate timeline, venue details, and a designated point of contact for the wedding day. The Client is responsible for obtaining any required photography permissions or permits. The Photographer is not responsible for missed images due to delays, late starts, venue restrictions, lighting limitations, weather conditions, guest interference, or schedule changes beyond the Photographer's control.

Guest Interference

The Photographer is not responsible for compromised coverage due to guests obstructing the Photographer's view, using flash photography during key moments, or otherwise interfering with the Photographer's ability to perform services. The Client acknowledges that cooperation from guests is essential to achieving desired results.

Meals and Breaks

For events exceeding six hours of coverage, the Client agrees to provide the Photographer with a meal and a reasonable break during the reception. Breaks will be taken during appropriate times and will not interfere with key moments.

Safety and Working Conditions

The Photographer reserves the right to cease coverage if working conditions become unsafe, hostile, or threatening. This includes but is not limited to intoxicated guests, unsafe environments, or requests that place the Photographer at risk. In such cases, no refund will be issued.

Copyright and Usage Rights

All images produced remain the sole property and copyright of Norton & Co. Photography. The Client is granted a personal use license for printing, sharing, and displaying images for non commercial purposes. Images may not be altered, sold, or used for commercial purposes without written permission. The Photographer retains the right to use images for portfolio, website, social media, advertising, and promotional purposes unless the Client submits a written request to opt out prior to the wedding date.

Image Archiving and Storage

The Photographer will archive final images for a limited period following delivery. Long term storage is not guaranteed. The Client is responsible for downloading, backing up, and preserving their images upon delivery. The Photographer is not responsible for image loss after delivery.

Limitation of Liability

In the unlikely event of equipment failure, data loss, illness, injury, or other circumstances beyond the Photographer's control that prevent the Photographer from fulfilling this agreement, liability is limited to a refund of all payments received. The Photographer will make reasonable efforts to secure a replacement photographer but does not guarantee replacement services.

Force Majeure

The Photographer shall not be held liable for failure to perform due to events beyond reasonable control, including but not limited to acts of God, natural disasters, government restrictions, pandemics, transportation failures, or emergencies. In such cases, liability is limited to the return of payments received, excluding the retainer.

Cancellation and Rescheduling

If the Client cancels photography services for any reason, the retainer is non refundable. If the wedding is rescheduled and the Photographer is available on the new date, payments may be transferred at the Photographer's discretion. If the Photographer is unavailable on the new date, the agreement will be considered canceled.

Indemnification

The Client agrees to indemnify and hold harmless Norton & Co. Photography from any claims, damages, or liabilities arising from the wedding event, including but not limited to personal injury, property damage, or claims related to photography permissions.

Entire Agreement

This agreement constitutes the entire understanding between the Photographer and the Client. Any amendments or modifications must be made in writing and signed by both parties.

Governing Law

This agreement shall be governed by the laws of the State of Texas.
